

Why do I Need a Fire Risk Assessment?

The Regulatory Reform (Fire) Safety Order; 2005 states that **all employers** '*must make a suitable and sufficient assessment of the risks to which relevant persons are exposed*'

So, any workplace or place in which the public are admitted must have a Fire Risk Assessment undertaken by a competent person.

Periodically your local Fire Authority may inspect your premises to check the adequacy of your fire safety arrangements and your Fire Risk Assessment


